Meeting Notes

The meeting was convened at 12:02 P.M. on December 7, 2015 in the ADC Conference Room by Chair, David Rosi after it was determined that a quorum was present.

Agenda Items:

- Introduction of guests Jason Malozzi and Shari Samuels from Kyle Hammon's instruction division
- Agenda items as identified
 - Petition Procedure (include sub-committee authority) approved
 - Academic Grievance (remove red type faced verbiage) approved
 - Academic Reinstatement Process (allow suspended students with temporary probation to enroll for next quarter) – approved, but revert to suspended and withdraw from next quarter pre-enrolled classes if a minimum of five credits with a 2.00 is not achieved. Work with Nichole to determine this process.
 - o Determine meeting dates and times for winter quarter
 - Tuesdays from 11 to noon 2nd Tuesday for full committee, 1st and 3rd Tuesday for subcommittee
 - Late withdraw Why 8th week? What about enforcement with petitions? This topic had lots
 of discussion and will be placed on the agenda for the January meeting. Take back to
 departments to gather additional input.
 - The 8th week cutoff has gone back and forth over several decades and is currently in place to meet financial aid requirements.
 - Late withdraw is typically approved if documentation is submitted for extenuating circumstances or a faculty/staff advisor provides written support.
 - Suggestions to take back for department discussion included developing a rubric of criteria to determine approval or denial, such as considering the level of coursework being attempted (pre-college or college level), using a tenth week cut-off (rather than established eighth week) prior to requiring an ASC petition, and auto approval by the Registrar if rubric criteria are met.

o Committee members reviewed one petition for late withdraw that included neither extenuating circumstances nor faculty support. The request was denied and it will be suggested that the student use the Retake Policy for grade improvement.

Members will be sent a meeting reminder and agenda or notice of cancellation prior to the next meeting which is currently scheduled for January 12, 2016 at 11:00 A.M. in ADC 144B.
