# **Discussion:**

HDEV 110 has not been taught in a long time due to low or not consistently projectable enrollments. Removal of the course won't change the scope of the certificate or core employability. For I-BEST students there is a need to keep the students moving sequentially through the program and HDEV 110 proved to be a barrier. All efforts will be made to get career exploration (Job Finding Skills) information to the students by other means. Total program credits are reduced from 50-52 to 47-49 (45 is minimum number of certification credits).

#### > Curriculum Review

To meet accreditation requirements every effort will be made to perform a regular review of course plans to keep content updated by developing a culture of evidence. A 4-year grid has been prepared and will be transmitted via email attachment to faculty showing a suggested cycle that diagrams how this task can be achieved. Faculty participation is strongly encouraged. The goal is to have at least one discipline reviewed in its entirety within one year. The area of Professional/Technical is under continuous review and criteria is updated on an ongoing basis with review occurring every three to five years depending on funding sources.
