- The Curriculum Review schedule was presented and reviewed. Members were urged to
  encourage work within their departments to ensure readiness to comply with the review
  schedule.
- When the ad hoc committees reviewed and revised the Diversity and Capstone course
  criteria the departments were given two years to review these courses under the new
  guidelines. These courses should be reviewed for adherence to new guidelines during the
  departmental review process. It is conceivable that any Diversity and Capstone courses
  not reviewed by the end of this academic year may be dropped from the existing lists.

#### Discussion:

Revise lecture hours from 11 to 0, add lab hours of 22. After running this on-line course for one year findings indicate an average of 12 to 28 hours are necessary to complete the course successfully. This change is in line with standard expectations of more independent work, discussion forums, time management, and worksheets. COLL 093 is structured the same with 1 cr, 22 lab hours. The type of activity determines instructor engagement - active teaching Vs coaching. Lab hours indicate course is activity based. Student outcomes as listed on the proposal form will be replaced with original student outcomes.

# Discussion:

Course meets Diversity criteria and was well received by the committee. Provides an understanding of the ethical systems and values of the world's various communities in order to gain an understanding of historical as well as contemporary moral, political and personal dilemmas. Course description was refined, Diversity will be marked under Distribution/Graduation Requirements. Gen Ed Outcome of Interpersonal Skills will be examined after one year for applicability and if determined so this course may be presented to the committee as an informational item.

# Proposal from Megan Jasurda (by Jon Kerr)

3. new course DANCE 110, Introduction to Tap Dance 2 cr, 11 lec, 22 lab

#### Discussion:

Course offers an introduction course to tap, basic dance theory and technique, and an understanding of American tap dance history. Should this course be on the Humanities distribution list? The ICRC drives the minimum requirements for this consideration and there is a limiting factor:

Humanities and Social Science (minimum 15 credits)

- 1. Minimum 5 credits in Humanities; and
- 2. Minimum 5 credits in Social Science; and
- 3. An additional 5 credits in either Humanities or Social Science for a total of 15 credits.

Should course be considered PHED? This course offers theory and analysis. Dance should be considered a Performing Arts class. Gen Ed Outcomes of Multiculturalism and Numeracy will be stricken at this time. Course can be presented at a later date with justification for these two items. Course will be added with Gen Ed Outcome of Interpersonal Skills only. Course description was refined.

### Discussion:

Course content focuses on fundamental concepts and does not require either a previous SPCH Communication course or completion of ENGL& 101 or ENGL 102 for students to be successful. There will be writing in the form of responses to essay questions, analysis of in-class small group activities, and analysis of the development and execution of a major group project. Assessment item of Research Paper is stricken, Student Outcomes and Course Description were refined. There are no prerequisites for this course.

#### Discussion:

Currently CS 109 is offered twice a year with limited times available for students. Offering this course in a BTEC lab format will allow for open enrollment from week 1 thru 7 of each quarter and will not be subject to a required number of students before the class can be offered as currently required. The BTEC format will allow for offering online versions of this course more easily when needed. Course title will be revised to PowerPoint Fundamentals and Assessment methods will show two bulleted items of 1)chapter tests, and 2)homework.
