## **ACTION/DISCUSSION ITEMS:**

• Distribution List Criteria:

If a course doesn't obviously fall into a particular distribution area how does this committee make assignment to the appropriate area? Should every transfer course be on the list?

ICRC Guidelines provide the following regarding Distribution Requirements: Within the distribution requirements, integrative, synthesizing courses and programs, including interdisciplinary courses and linked sequences of courses, are to be encouraged, especially for colleges requiring a minimum of two disciplines per area. (From ICRC Handbook – page 7). Appendix B lists general disciplines with exclusions only. If the course isn't listed as an exclusion, is it automatic that we add it to the Distribution List? The ICRC outlines what we can and can't do and we don't want to put something different in place. All of our current courses went through the Curriculum Committee and doing so would bring all of those decisions into question. The ICRC recognizes the breadth and depth of the individual courses while limiting the number of restricted credits to 15 (not more than explicitly allowed under the guidelines).

It was concluded that the ICRC doesn't provide enough specific guidelines and we need to articulate our criteria for selection to the Distribution List. Mark Bergeson and Kyle Hammon

- Common Course Numbering of ENGL 102 has been approved by SBCTC. Course number will now be ENGL 102 and entitled *Composition II*.

# Proposals from Dennis Shaw to add new Diversity course and revise one course:

1. new course ANTH 109, American Cultural Diversity:DIV 5 cr, 55 lec

## Discussion/rationale:

Course will promote a comprehension of the varied social and cultural factors which produce the rich diversity of the US. Central to this analysis will be a crucial understanding of the role social identities (face, ethnicity, class and gender) play in self-conceptualization and group affinity. Moreover the class will evaluate the general patterns of exclusions and the limits they place on individual success. Additions to the Gen Ed Outcomes are: Communication and Critical Thinking. Dennis will collaborate with Andrea to ensure required/recommended titles are available in the Learning Commons.

#### Resolution:

## Discussion/rationale:

This course, as originally constructed, will not be resubmitted for consideration under the new Diversity guidelines. Instead, a new class has been developed (ANTH 109) which will meet the expectations of the degree requirement and meet the general expectations of the Social Science area of the distribution list. Diversity is a local requirement - not statewide. 100 and 200 level courses are treated equally at the university level. This course would be reflected as meeting LCC's diversity requirement for students enrolled through the current catalog date. ANTH& 206 remains on the books and is now flagged as an Intermittent Capstone. Additions to the Gen Ed Outcomes are: Communication and Critical Thinking.

## Proposal from Adam Wolfer to add new course:

3. new course PHSC 108, Physical Science 5 cr, 44 lec, 22 lab

## Discussion/rationale:

This is a specialized physical science course for Elementary Ed and Early Child Ed majors that focuses on the content of the physical sciences and has an emphasis on teaching the concepts to pre K-8 students. It is part of a 3-quarter sequence for those education majors. The significant difference between PHSC 108 and PHSC 109 is that the education focus is not appropriate for 108 so it has been removed. Since content is similar in the two courses, students who have taken one would not benefit significantly from taking the other, and so should not get credit for both.

#### Discussion/rationale:

Changes are in the best interest of the students. The original proposed change would have been to include BUS 210 along with MATH 210 (both entitled Elements of Statistics and essentially are the same class), but other schools may not accept BUS 206 as meeting a Math requirement. LCC is willing to petition, if necessary, for those who've already taken BUS 206. The Master Plan for Nursing in WA recommends that all RNs attain a bachelor's degree within 10 years of entering the profession, beginning in 2020. Requiring Elements of Statistics in place of Intermediate Algebra prepares nursing students for advancement to the next level of nursing education, as this is a consistent prerequisite course at four-year institutions. With the emphasis in nursing on evidence-based practice, requiring Elements of Statistics better prepares students with the knowledge base necessary to understand and evaluate "evidence". This change has been approved by the Nursing Advisory Committee in June 2010.
