Rationale: Modifying course description and outcomes to reflect cultural diversity, to foster the development of culturally competent educators, and to meet state requirements. Education course Vs. course teaching Diversity. Majority of the outcomes deal with Diversity issues.

Rationale: Revisions provide clarity in the intended learning outcomes while correcting several grammatical errors introduced in the

prior versions. The catalyst for the review was the College's review of the Diversity Distribution List. Resolution: Dan made a motion to approve BUS 144 as written: 3 nays, 2 abstentions: motion approved as Diversity Course. Dan made a motion to approve the revisions to BUS 150 but not the Diversity portion; Courtney seconded. Motion carried with 1 abstention. Effective: Fall 2013 4. new course BUS 270, Introduction to Project Management 5 cr, 44 lec, 22 lab (New Technical Elective for Business Management AAS) Rationale: Knowledge of, and skills in, project management are common, if not universal, critical success requirements of managers in many business settings. In addition to supporting the students pursuing the new AAS Administrative Services Manager Degree, we expect many students pursuing the AAS Business Management Degree will elect to take the course as an elective. Current business practitioners in the community may also complete the course for specific skills augmentation. The course will effectively prepare successful completers to sit for the PMI Certified Associate in Project Management (CAPM) examination. Resolution: Minor rewording of the description; distribution will reflect 'elective' only; prerequisites were shortened for clarity. This effort is to better align the course outcomes with the Microsoft Certification exams and the current needs of industry. Resolution: Course descriptions will be reworded outside of this meeting. Dan made a motion to approve pending modifications; Sue seconded. Motion carried. Effective: Fall 2013 **CS 121,** Introduction to Spreadsheets 5 cr, 55 lec 10. revise course (Prerequisites, Outcomes) Rationale: Course revision removes CS 111 prerequisite that was put into place last year for accounting majors. It was realized that students completing CS 111 rather than CS 110 were not as prepared for this course. Therefore, the accounting program replaced CS 111 with CS 110. Outcomes are updated in relation to the article review component to encourage students to research new Resolution: Minor rewording of description. Course will now cover complete coverage of PowerPoint features. Resolution: Minor rewording of description; revisions to outcomes are pending. Sue made a motion to approve; Dave Cordero seconded. Effective: Fall 2013 **Proposal from Don Derkacht:** CS 281, Digital Design & Computer Organization (was Digital 5 cr. 44 lec. 22 lab 12. revise course

(was 6 cr, 33 lec, 66 lab) (Title, Cr/Lec/Lab, Description, Outcomes, Assessment Methods)

Rationale: CS 281 is offered to WSU-V computer science transfer students. The equivalent course at WSU-V has changed focus from design and analysis to digital design and then moves on to the architecture of microprocessors. The lesser focus on digital design still establishes the necessary foundation to be able to understand the elementary digital logic that undergirds a more abstract approach to understanding the architecture of the modern microprocessor. The course outcomes now omit the parts of digital design that are not really necessary and now include and parallel the concepts on which CS 260 (WSU-V) now focuses.

Resolution: Minor rewording to description; Sue made a motion to approve with suggested amendments; Dawn seconded. Motion carried. Effective: Fall 2013

Rationale: Revisions are to update course requirements intended to prepare students for the latest certification exams. All three courses require some use of our library; however, it does not change from previous use. The CS211 course is required of all CS majors. CS 212 and CS 213 are required by students working toward the networking option of the CS programs. They are also offered to community students already working in the field who may wish to upgrade their skills or review for certification.

Rationale: Concurrent requirement on each course is more in keeping with music programs at other institutions. Students learn more efficiently in a lecture setting which incorporates demonstration and direction from the instructor, as well as guided group participation. The Ear Training sequence offers valuable skills to musicians and is specifically paired with the Theory and Musicianship sequence to provide practical, performance-based application of theoretical content. Updated outcomes, descriptions, and lec/lab designations reflect these changes.

Resolution: Global Skills will not reflect 'critical thinking'; course outcomes and description need to be updated to show progression; David made a motion to approve pending suggested amendments; Sue seconded. Motion carried.

Rationale: Instruction in advanced music theory can take many different directions and is therefore less likely to transfer to other institutions than basic (1st year) music theory. Also, due to the increasing difficulty of advanced music theory classes, many students lose interest and the attrition rate from 1st to 2nd year can be high. The Ear Training courses (IV, V, and VI) are appendages of Advanced (Music) Theory; it would not be feasible to continue them for the same reasons.
