Opening remarks were made by Karen Joiner.

Reminder of timing of prerequisite changes – prerequisites go into effect at a specific date – but need to make allowances for students who may have begun a program at an earlier date and may not have taken the specific "new" courses.

Proposals from Elena Ross: HLTH 245, Health and Exercise Behavior Change 3 cr, 33 lec **A.** new course Rationale: This course is being created for the Health and Fitness Specialist Certificate but it could also be used as an elective course. This course is being created for this program at the request of the community advisory committee. Resolution: Darlene made a motion to approve with suggested amendments to description and outcomes; Mindy seconded. Motion carried. Effective: Winter 2016 PHED 285, Fitness Marketing 3 cr, 33 lec **B.** new course Rationale: This course is being created for the Health and Fitness Specialist Certificate but it could also be used as an elective course. This course is being created for this program at the request of the community advisory committee. Course could be crosslisted with BUS 268 (proposed new course shown below). Resolution: Darlene made a motion to approve (but not cross-list at this time) with suggested amendments to description and outcomes; Tamara seconded. Motion carried. Effective: Winter 2016 **C.** new certificate **Fitness Instructor-COC** 19 cr total Rationale: This certificate will provide an avenue for students to be prepared and educated for a career working as a personal trainer and/or fitness class instructor at fitness clubs, on their own, or teaching community education classes. There are many job opportunities in this field of work within this community, however, there are no local avenues for training individuals seeking this type of position. Resolution: Kyle made a motion to approve; Nicole seconded. Motion carried. Effective: Winter 2016 **Proposals from Nadine Lemmons: D.** new course BTEC 156, Intro to MS Visio 3 cr, 22 lec, 22 lab Rationale: New course supported at Fall 2015 Advisory meeting. Students in the BTEC Admin Services Mgr AAS program, and any BUS/CS/IT program would benefit from taking this course as it is a growing application used in business planning, data modeling, and programming. This class will initially be offered as an elective option for both BTEC and BUS/CS/IT programs, but may become a prerequisite to courses in future curriculum revisions. Global Skills will reflect Communication and Critical Resolution: Dave made a motion to approve with suggested amendment to description and Global Skills; Nicole seconded. Motion carried. Effective: Summer 2016 E. new course BTEC 157, Intro to MS Project 3 cr, 22 lec, 22 lab Rationale: New course supported at Fall 2015 Advisory meeting. Students in the BTEC Admin Services Mgr AAS program, and Business Mgmnt AAS program would benefit from taking this course as it is a growing application used in business and project management. This class will initially be offered as an elective option for both BTEC and BUS, but may become a prerequisite to courses in future curriculum revisions, more specifically BUS 270 Intro to Project Management. This could also be used as possible elective for CS/IT or other Vocational programs. Global Skills will reflect Communication and Critical Thinking.

Resolution: Nicole made a motion to approve with suggested amendments to Global Skills; Melinda seconded. Motion carried. Effective: Summer 2016

Proposal from Tim Allwine presented by Elena Ross:

F. new course BUS 268, Fitness Marketing 3 cr, 33 lec

Rationale: This course is being created for the Health and Fitness Specialist Certificate but it could also be used as an elective course. This course may be cross-listed with PHED 285.
