INFO 1 - LPN2RN Campus Based Opt-in Option AN-DTA/MRP, LPN2RN eLearning AN-DTA/MRP,

Registered Nurse AN-DTA/MRP: Revise the planners to require NUTR& 101 prior to beginning NURS courses, and "highly recommend" HUM/DIV course be taken prior.

INFO 2 – MUSC 111/112/113: Removing the following information from the course plan descriptions: "Supports the musicianship portion of the MUSC 101 (or 102 / 103) coursework."

Proposals from Michaela Jackson:			
C.	Revise Course	OLTM 440, Ethics and Leadership: Leading and Managing in a Diverse Society	5 cr, 55 lec

Rationale: This course advances knowledge of diverse cultures, cross-cultural communication, the dynamics of privilege and oppression, and the uses of power between groups. To develop cultural competency, leaders need to know themselves, others, the relevant issues, and have an appreciation and curiosity for working with others. Students will differentiate between ethical actions in relation to the greatest good, individual rights, justice, and the common good, and identify how this influences decision making.

D. Revise Course **EDUC 319**, Anti-bias Education

5 cr, 55 lec

Rationale: This course explores how embedded bias can impact identity development, and supports students in deconstructing their biases. Students will reflect on biases existing in the communities of schools and societal systems. Equity issues in education are examined and strategies are presented to help students apply the principles of anti-bias education to instruction. Students are provided opportunities for peer and instructor coaching to improve responsiveness to cultural, linguistic and ability diversity. There are course discussions on culturally relevant pedagogy and its importance to the transmitting of culture from generation to generation.
