Informational Items:

INFO 1 – Education AAS follow-up: Ashleigh Kruckenberg submitted her corrected degree requirements template after the November meeting. Follow-up complete and noted toward the end of the November minutes. (A grammatical correction was suggested for the third program outcome (removal of the first and, substitute comma).

INFO 2 – Administrative Services Manager AAS/AAS-T, Hospitality & Convention Services Management COC, and BTEC 126/127/128 follow-ups: Mark Gaither provided the revised AAS/AAS-T degree requirements page, as well as advisory committee minutes. The follow-up is complete and noted toward the end of the November minutes.

INFO 3 – EDUC 300: Adding permission to drop requirement. Students who drop EDUC 300 cannot continue in the BAS-TE program. Dropping the course impacts FA eligibility and program progression. Requiring drop permission will ensure students are informed of the ramifications prior to the drop. Proposal Items:

Rationale: LCC's Production Technician COP was aligned with the Advanced Manufacturing AAS which is being terminated as the new AAS in Automation, Instrumentation and Robotics (AIR) is in development. Only minor changes are needed to the current Production Tech COP to align with the new (AIR) degree. Based on industry feedback and direction from the employer focus group, we are requesting to update the title to Industrial Maintenance to better align with current industry job postings and labor market demand (as well as local apprenticeship agreements). In addition, requesting to remove three courses that have been adjusted based on the changes to the AIR degree and adding four classes. Overall, these changes enhance student foundational studies, MFG 100 and the PLC and instrumentation coursework has been expanded into several courses to cover the topic in more depthas recommended by the focus group guidance.
